Your interest in this program demonstrates the commitment your company has in improving the security of our global supply chain. Collaborating with Sanmina and SCI Corporations is taking a positive step in enhancing the security of our supply chain and the fight against global terrorism.

Sanmina and SCI became a certified member of CTPAT on March 19, 2004 and validated on July 25, 2007 with Exceeding Tier III status as **"Best in Class"**. Our membership categories are under three guidelines – Global Importer; Canadian Importer; and Mexico Foreign Manufacturer requirements and criteria.
